• Classification, Dues and Assessments

1. Rubber Producer: Any enterprise that processes or supplies ground tire rubber for use in asphalt paving materials. \$2000 Annual Membership fee*+

“User” members (contractors) shall remit an assessment of \$0.01 per each pound of crumb rubber used in asphalt applications** up to \$48,000.00/year. If the cap is met during the year there are no further assessments to be made.

“Producer” members shall remit an assessment of \$0.003 per each pound of crumb rubber sold into asphalt paving applications up to \$25,000.00/year. If the cap is met during the year there are no further assessments to be made.

2009 New Member policy provides user or producer eligible companies to join as regular members with a one year reduced assessment rate, 50% of the current per pound assessment on the sale or use of crumb rubber in asphalt paving applications. Rate for user = \$0.005 per each pound of crumb rubber. Rate for producer = \$0.0015 per each pound of crumb rubber.

**Plus monthly poundage assessment of crumb rubber sold into asphalt paving applications.*

+Eligible to serve on the Association Board of Directors after a 2.5 million pound qualification in usage or production of crumb rubber assessments paid into the association prior to BOD voting eligibility.

***Asphalt applications include: Wet Process, Dry Process, Terminal Blends, and Rubberized Slurry Seals.*

Applications for membership will not be presented to the Board of Directors unless a check for dues in United States Dollars is included.
